The Application is provided for technological demonstration and evaluation purposes only. It is not intended for production, critical, commercial, or reliance-based use.

2 Description of Service

<ephcall/> is a browser-based peer-to-peer voice application with authenticated session establishment and optional insertable-stream media encryption, depending on browser capability and session policy settings.

Features, behavior, and availability may change, be limited, or be discontinued at any time without notice.

3 User Responsibilities

You agree that:

- You are responsible for lawful use of the Application.
- You are responsible for device and endpoint security (OS/browser updates, malware hygiene).
- You are responsible for secure exchange and management of handles, peer IDs, and shared secrets.
- You understand that weak or disclosed shared secrets may reduce session security.

4 Privacy and Data Handling

- Voice traffic is intended for direct peer-to-peer transport after signaling.
- The Application does not intentionally store voice content on central servers.
- Session runtime state is designed to be ephemeral and cleared on reset/disconnect.
- Browser capability differences can lead to transport-only mode when insertable-stream E2EE is unavailable.
